## Add-in License Agreement

Access to LSEG® data and tools is provided through either of the following separately installed add-ins:

- **Workspace**
- **Workspace Lite**

For further information about the requirements for these Add-ins and LSEG Workspace, refer to the [Technical documentation section](#) of the LSEG Workspace site.

This document describes the License Agreement for customers using the Workspace add-in.

## License agreement

Only licensed Customers are permitted to download the Add-In. The Add-In is provided under license for Customers of LSEG Workspace and is subject to the terms and conditions of the relevant services contract agreed between the Customer and relevant member of the LSEG Group for LSEG Workspace, which terms and conditions shall apply to the Add-In.

"Customer" means the entity which has authorized you to use LSEG Workspace and the Add-In.

"LSEG Group" means Refinitiv Limited (including their successors) and any entity that, from time to time, is directly or indirectly controlling, controlled by or is under common control of such entities. An entity will be deemed to control another entity if it has the power to direct or cause the direction of the management or policies of such entity, whether through the ownership of voting securities, by contract, or otherwise.

## Export control and sanctions

By downloading, installing or using the Add-In, you agree that you:

1. are not located, established, incorporated or ordinarily resident in, or a citizen of, a country or region subject to comprehensive sanctions measures or in any country to which the UK, the US, the EU or an EU member state prohibits exports ("Prohibited Destination");
2. are not subject to targeted sanctions or restrictive trade measures maintained by the UK, the US, the EU or an EU member state ("Prohibited Person") or acting on behalf of a Prohibited Person;
3. will not export, re-export, release, transfer or otherwise make available the Add-In, or any direct product of it, to any Prohibited Destination or Prohibited Person (as defined at paragraphs 1 and 2 above), or for any purpose that is prohibited under UK, EU, US or other applicable export control or sanctions laws;
4. will not use, or allow anyone else to use, the Add-In in connection with the design, development, production or use of biological, chemical or nuclear weapons or related missile delivery systems, military end-use, or any end-use that is prohibited by law;
5. are solely responsible for complying with all applicable export control, sanctions, customs and trade laws and regulations in connection with the download, installation, use or transfer of the Add-In; and
6. will immediately stop using the Add-In and uninstall all copies if you no longer meet the commitments in paragraphs 1-5 above.
